AIMS AND SCOPE

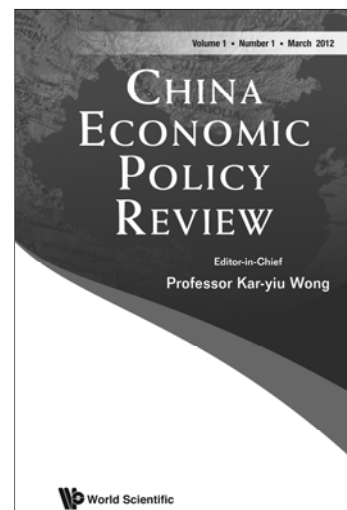
